First, No Place to Call Home Coordination provides a single point of entry and assessment into the program for those who are homeless. Second, No Place to Call Home coordinates case management providers in the county and assigns clients to the most appropriate provider based on their presenting needs. Third, No Place to Call Home coordinates financial resources for clients to assist in addressing their housing needs.
